- (1) for an amount of litter not exceeding three (3) pounds in weight and not for commercial purposes, a fine of fifty dollars (\$50.00), for the first offense, one hundred fifty dollars (\$150.00) for the second offense and five hundred dollars (\$500.00) for each subsequent offense thereafter;
- (2) for an amount of litter equal to and exceeding three (3) pounds in weight but not exceeding fifty (50) pounds in weight and not for commercial purposes, a fine of five hundred dollars (\$500.00);
- (3) for an amount of litter exceeding fifty (50) pounds in weight or for commercial purposes, a fine of one thousand dollars (\$1,000.00);
- (4) in addition to the penalty provided by this subsection, a court may order the violator to:
  - (a.) Remove or render harmless the litter dumped in violation of this section;
  - (b.) Repair or restore property damaged by, or pay damages for, any damage arising out of dumping the litter in violation of this section;
  - (c.) Perform public service relating to the removal of litter dumped in violation of this section or to the restoration of any area polluted by litter dumped in violation of subsection (b.)(1) of this section; or
  - (d.) Reimburse the Town for any costs incurred in the removal of litter dumped in violation of subsection (b.)(1) of this section.

- (B) Unless otherwise specified either above or elsewhere, the fine for a municipal infraction shall be fifty dollars (\$50.00) for the first offense and one hundred dollars (\$100.00) for each repeat offense and the fine for a misdemeanor shall be one hundred dollars (\$100.00) for a first offense and two hundred dollars (\$200.00) for each repeat offense. The fine for all municipal infractions, whether or not it is indicated above in this Subsection or in Subsection a above shall double pursuant to Article 23a, §3(b)(5) upon the failure of the person charged either to pay the fine by the date set forth in the citation or to deliver to the Town written notice of intent to stand trial.
- (C) Unless otherwise specified either above or elsewhere, the fine for a parking violation shall be forty dollars (\$40.00), and upon the failure to request a trial or pay the fine within (15) fifteen calendar days of the issuance of the citation, the fine doubles to eighty dollars (\$80.00).
- (D) When parking fees are unpaid, the Town can also "flag" a vehicle or license at the Motor Vehicle Administration. The Town may set a reasonable fee for such "flagging" of at least twenty-five dollars (\$25.00) or the amount set by the Budget Ordinance.
- (E) Unless otherwise specified either above or elsewhere, the fine for a traffic violation shall be fifty dollars (\$50.00), and upon the failure to request a trial or pay the violation within fifteen (15) calendar days of the issuance of the violation notice, the fine doubles to one hundred dollars (\$100.00).
